I am imploring you to advocate for the students of the Lacev Township School District, who have lost \$13.7 million in state aid over the past seven years. Our district also just learned that all districts will not be permitted to ask for any loans to help balance our budgets for the 2024-2025 school year. This will have unimaginable consequences for the Lacey Township School District. Our district has already cut 141 positions including teachers, administration, and support staff; made cuts to athletics including all freshman sports; reduced all co-curricular budgets, all educationally valuable field trips; reduced elective class offerings at the middle and high schools; and eliminated courtesy busing.

We are fiscally sound. We do not have a spending problem - we have a REVENUE problem caused by the reduction of state aid.

Why should our students have fewer programs, services, athletics, co-curriculars and opportunities?

I respectfully ask that you consider a short-term plan to support this urgent matter now; and long-term plan to fix the broken funding formula.
