NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Lacey Township Board of Education, that the Lacey Township Board of Education does hereby join with the Township of Lacey in applying for a LEAP challenge grant to support undertaking this endeavor.

RESOLUTION OF THE BOARD OF EDUCATION OF THE TOWNSHIP OF LACEY IN THE COUNTY OF OCEAN, NEW JERSEY AUTHORIZING THE SUBMISSION OF THREE BOND PROPOSAL QUESTIONS TOGETHER WITH AN EXPLANATORY STATEMENT TO THE SCHOOL DISTRICT VOTERS AT A SPECIAL SCHOOL DISTRICT ELECTION TO BE HELD ON MARCH 11, 2025

MOTION: BE IT RESOLVED BY The Board of Education of the Township of Lacey in the County of Ocean, New Jersey (the "Board") (not less than a majority of the full membership of the Board concurring) as follows:

1. The following three bond proposals (the "Proposals"), together with explanatory statement ("Explanatory Statement") shall be submitted to the legal voters of the School District at a

special School District election (the "Election") to be held on Tuesday, March 11, 2025 commencing at 7:00 a.m. for the purposes hereinafter provided. The polls shall remain open until 8:00 p.m. and as much longer as may be necessary to permit all the legal voters then present to vote and cast their ballot. The form of the Proposals and together with the Explanatory Statement will read substantially as follows except as otherwise may be set forth herein:

BOND PROPOSAL QUESTION NO. 1

The Board of Education of the Township of Lacey in the County of Ocean, New Jersey (the "Board") is authorized to (a) undertake the replacement of various portions of roofing at Lacey Township High School, Lacey Township Middle School, Cedar Creek Elementary School, Forked River Elementary School, Lanoka Harbor Elementary School, and Mill Pond Elementary School, including any site work; (b) undertake various HVAC upgrades, alterations and improvements at Lacey Township High School and Lacey Township Middle School, including acquisition and installation of fixtures, equipment and any site work; (c) appropriate \$29,958,000 for such improvements; and (d) issue bonds in an amount not to exceed \$29,958,000.

The Board of Education of the Township of Lacey in the County of Ocean, New Jersey (the "Board") is authorized to (a) undertake various upgrades, improvements, alterations and renovations to the gym and locker rooms, and to acquire and to install a multi-purpose synthetic turf field with lighting at Lacey Township High School, including acquisition and installation of fixtures, furniture, equipment and any site work; (b) undertake various upgrades, improvements, alterations and renovations to the locker rooms at Lacey Township Middle School, including acquisition and installation of fixtures, furniture, equipment and any site work; (c) undertake various paving improvements at Cedar Creek Elementary School and at Lanoka Harbor Elementary School, including any site work; (d) undertake various paving improvements and toilet room renovations at Forked River Elementary School, including acquisition and installation of fixtures, equipment and any site work; (e) undertake various upgrades, improvements, alterations and renovations to the media center, toilet rooms, locker replacement, paving improvements, and repaving the basketball courts at Mill Pond Elementary School, including acquisition and installation of fixtures, equipment and any site work; (f) appropriate \$24,544,500 for such improvements; and (g) issue bonds in an amount not to exceed \$24,544,500.

The final eligible costs for the projects approved by the New Jersey Commissioner of Education are \$21,461,138 (consisting of \$6,021,638 for Lacey Township High School, \$1,350,000 for Lacey Township Middle School, \$1,857,500 for Cedar Creek Elementary School, \$3,562,500 for Forked River Elementary School, \$4,050,000 for Lanoka Harbor Elementary School, and \$4,619,500 for Mill Pond Elementary School). The projects include \$3,083,362 (consisting of \$3,083,362 for Lacey Township High School, \$0 for Lacey Township Middle School, \$0 for Cedar Creek Elementary School, \$0 for Forked River Elementary School, \$0 for Lanoka Harbor Elementary School, and \$0 for Mill Pond Elementary School) for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this election.

EXPLANATORY STATEMENT

At this election, the voters of the school district are being asked to consider Bond Proposal Questions No. 1, No. 2, and No. 3. As set forth above, Bond Proposal Question No. 2 will only go into effect if Bond Proposal Question No. 1 is also approved by the voters at this election, and Bond Proposal Question No. 3 will only go into effect if Bond Proposal Question No. 1 is also approved by the voters at this election.

If Bond Proposal Questions No. 1, No. 2, and No. 3 are approved by the voters at this election, the Board of Education will be authorized to (a) undertake the replacement of various portions of roofing, various HVAC upgrades, alterations and improvements, various upgrades, improvements, alterations and renovations to the gym and locker rooms, and to acquire and to install a multi-purpose synthetic turf field with lighting at Lacey Township High School, including acquisition and installation of fixtures, furniture, equipment and any site work; (b) undertake the replacement of various portions of roofing, various HVAC upgrades, alterations and improvements, various upgrades, improvements, alterations and renovations to the locker rooms at Lacey Township Middle School, including acquisition and installation of fixtures, furniture, equipment and any site work; (c) undertake the replacement of various portions of

roofing, various HVAC upgrades, alterations and improvements, various paving improvements at Cedar Creek Elementary School and at Lanoka Harbor Elementary School, including acquisition and installation of fixtures, equipment and any site work; (d) undertake the replacement of various portions of roofing, various HVAC upgrades, alterations and improvements, various paving improvements and toilet room renovations at Forked River Elementary School, including acquisition and installation of fixtures, equipment and any site work; and (e) undertake the replacement of various portions of roofing, various HVAC upgrades, alterations and improvements, various upgrades, improvements, alterations and renovations to the media center, toilet rooms, locker replacement, paving improvements, and repaving the basketball courts at Mill Pond Elementary School, including acquisition and installation of fixtures, equipment and any site work.

The total cost for the projects will be \$92,477,980, and the Board of Education will be authorized to issue bonds in an amount not to exceed \$92,477,980. The final eligible costs for the projects approved by the New Jersey Commissioner of Education are \$89,394,618 (consisting of \$28,569,638 for Lacey Township High School, \$7,878,750 for Lacey Township Middle School, \$10,421,105 for Cedar Creek Elementary School, \$8,843,125 for Forked River Elementary School, \$7,729,500 for Lanoka Harbor Elementary School, and \$25,952,500 for Mill Pond Elementary School). The projects include \$3,083,362 (consisting of \$3,083,362 for Lacey Township High School, \$0 for Lacey Township Middle School, \$0 for Cedar Creek Elementary School, \$0 for Forked River Elementary School, \$0 for Lanoka Harbor Elementary School, and \$0 for Mill Pond Elementary School) for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this election.

- 2. The Board hereby approves and adopts the Proposals and Explanatory Statement set forth above and, subject to the approval of the legal voters of the School District, hereby determines to carry out the same as described therein (the "Project"). The Board authorizes the Business Administrator/Board Secretary, consistent with any advice received from bond counsel, to revise the Proposals and/or Explanatory Statement, if necessary, prior to the Election to conform to any applicable legal requirements.
- 3. The Board hereby acknowledges and confirms that, in accordance with the requirements of N.J.S.A. 18A:24-16 and N.J.S.A. 18A:24-17, a Supplemental Debt Statement has been prepared as of the date of this resolution by the Chief Financial Officer of the Township of Lacey, giving effect to the proposed total authorization of School Bonds of the School District in the maximum amount provided for in the Proposal, and that each Supplemental Debt Statement has been filed in the office of the Township Clerk, in the office of the Business Administrator/Board Secretary prior to the adoption of this resolution, and will be filed in the office of the Director of the Division of Local Government Services, State of New Jersey, Department of Community Affairs prior to the date of the Election.
- 4. The Business Administrator/Board Secretary is hereby authorized and directed, in conjunction with Bond Counsel, to deliver a certified copy of this resolution and such other information as shall be necessary to the County Clerk as required by N.J.S.A. 19:60-2, to request the County Clerk to submit the Proposal to the voters at the Election and to seek the assistance of the county officials and the municipal clerk in conducting the Election.
- 5. The Board hereby: (i) accepts the determination of Preliminary Eligible Costs as set forth in the letter from the New Jersey Department of Education and not to appeal such determinations made therein; (ii) determines to construct the Project itself; (iii) agrees to locally fund any

excess costs, if any; and (iv) delegates the supervision of the Project to the Business Administrator/Board Secretary.

- 6. Fraytak Veisz Hopkins Duthie, P.C., the School District's appointed architect for the Project (the "Project Architect"), has heretofore been authorized and delegated the responsibility to prepare the plans and specifications for the Project in consultation with and under the supervision of the Business Administrator/Board Secretary, who has been delegated the responsibility to work with the Project Architect for this purposes on behalf of the Board, in accordance with the requirements of N.J.S.A. 18A:18A-16, and such authorizations and delegations are hereof reconfirmed.
- 7. The School Administration and such other officers, professionals and agents of the Board as are necessary, including Wilentz, Goldman & Spitzer, P.A., Bond Counsel, and the Project Architect, are each hereby authorized and directed to perform such acts, execute such documents and do such things as are necessary and proper for the submission of the Proposal to the voters of the School District at the Election.
- 8. This Board hereby makes the following covenants and declarations with respect to obligations determined to be issued by the Business Administrator/Board Secretary through a public offering of private placement or through a conduit borrower on a tax-exempt basis. The Board hereby covenants that it will comply with any conditions subsequent imposed by the Internal Revenue Code of 1986, as amended (the "Code"), in order to preserve the exemption from taxation of interest on its bonds or notes if issued as tax exempt, including, if necessary, the requirement to rebate all net investment earnings on the gross proceeds above the yield on its bonds or notes. The Business Administrator/Board Secretary is hereby authorized to act on behalf of the Board to deem the obligations authorized herein as bank qualified for the purposes of Section 265 of the Code, when appropriate. The Board hereby declares its intent to issue bonds or notes in the amount set forth in the Proposal approved by the voters as set forth in Section 1 and to use the proceeds to pay or to reimburse expenditures for the costs of the Projects authorized herein. This resolution is a declaration of intent within the meaning and for the purposes of Treasury Regulations 1.150-2 or any successor provisions of federal income tax law.
 - 9. This resolution shall take effect immediately.
