ADMINISTRATIVE CONTRACT

MOTION:

- WHEREAS, William W. Zylinski ("Employee") is currently employed by the Lacey Township of Education ("Employer") as Assistant Superintendent for Curriculum and Instruction for the Lacey Township School District; and
- WHEREAS, as of September 1, 2024 there will exist a temporary vacancy in the position of Superintendent of Schools; and
- WHEREAS, effective on such date Employee has been assigned to the position of Acting Superintendent of Schools and has consented to such assignment; and
- WHEREAS, pursuant to the Agreement between William W. Zylinski and the Lacey Township Board of Education, Employee is entitled to receive a pay differential for such time as he serves in the position of Acting Superintendent of Schools.
- NOW, THEREFORE, BE IT RESOLVED commencing on September 1, 2024, and continuing for a period not to exceed June 30, 2025, William W. Zylinski shall serve in the position of Acting Superintendent of Schools, and shall be paid an annual salary rate of \$212,000.00, prorated for such period as he may serve in the position of Acting Superintendent of Schools as approved by county office.
